As per the guidelines from the Kerala State Higher Education Council, Mahatma Gandhi University has implemented Choice based Credit and semester System with Grading for undergraduate courses from 2009 Admission onwards and the Regulations for the same was approved vide U.O.No.2599/AIII/2009/Admn dated 20.06.2009.

The Chairmen of the Boards of Studies in Under Graduate courses have recommended the following amendment to item No.8 Programme Structure included in the Regulations for Under Graduate programmes under Choice based Course – Credit – Semester System and Grading, 2009. The original programme structure is applicable for Model I UG Courses. The modified Item No. 8 of Regulations for U.G. programmes under CBCSGS 2009 is detailed below:

Minimum attendance required	75%


