Curriculum should accommodate more elective courses.	BCom Programme was modified with an introduction of optional courses-(a)Finance and Taxation (b) Co-operation. Mcom Programme introduced Management Accounting as an elective subject.
Ensure that the curriculum has content relevant to local/national/regional and global development needs	Integrated issues relevant to local/national/regional and global development needs into the curriculum. PSOs and Cos are designed in line with UN Sustainable Development Goals. Inclusion of research projects and field surveys in curricula to identify problems faced by the local people. Incorporation of national study tours as part of the curriculum to have exposure to the cultural diversity of the nation. Foreign languages are offered at degree level to develop global competencies.
Need for starting advanced courses pertaining to contemporary social and industrial needs.	Introduced a new programme- MA (Communication and Media Studies) As suggested by Rehabilitation Council of India, started a new PG diploma programme on Disability Rehabilitation and Management
Received suggestions to provide soft skill training for students	Based on the feedback, more soft training workshops were organized for students.
Suggestions were received to introduce professional courses	BCom syllabus was modified catering to the needs of CA/CMA courses
Stakeholders expressed the need of coaching for competitive exams	Coaching was given to students for different competitive exams (NET coaching, Bank Coaching, IELTS training etc.)
Need for courses pertaining to technological advancements	Introduction of a course titled Creative and Technical Writing as it provides inputs on new media writing including writing for the web and social media.









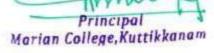
