Suggestions by Stakeholders	Action Taken
Need for introducing new discipline	Started four-year B.Sc Hons. (Physics)
Introduce more diploma and certification courses	New Diploma programmes like Counselling and Psychotherapy, Research and Teaching and Digital media were introduced.
Promote the interest of students in e- learning	Inclusion of SWAYAM courses as extra credit courses for all UG and PG programmes.
Stakeholders from industry pointed to the need of courses catering to the industrial needs	Initiated academic tie-up with Tata Consultancy Services (TCS) and modified 8 courses in the syllabus offered by BBA department. Add-on courses pertaining to technological needs were introduced. Add-on course titled 'Internet of Things' was incorporated into the syllabus of BCA programme Courses like Machine Learning and Cloud Computing were offered by the MCA department.
Research quality may be enhanced	Turnitin- Plagiarism software was made available in the college library for free quality check of research manuscripts. It was decided to include more topics related to research aptitude and skills
Need for vocational courses in the curriculum	As per the feedback received, MVoc Programme in Rubber & Polymer Technology and PG Diploma in Flexible Electronic Technology were introduced.
Include more value-added courses and internship programmes	Value added courses related to general aptitude and soft skill development were incorporated into the curriculum
Need for more certificate courses	Certificate courses in Project Proposal Writing and PC Assembling and Laptop Repairing were added to the syllabus of MCA programme
Topics of contemporary relevance, both cultural and social, should be included in the curriculum	Courses like Women in Media in India, Gender and Tourism, Gender and Development, Culture and Cinema were added into the curriculum of certain programmes
Need for more community-oriented courses	Contents of certain courses were modified with a focus on community service
